Patrick (Pat) McNulty of 1817 VIA TIVIERNO, Roselle CALIF 95747 [address], being first duly sworn, says that I have firsthand knowledge of a map my brother Bill McNulty and I received from our Coast Guardsman brother in-law Gary Newman and the story regarding the original 420 Waldos and origins of the term '420-four twenty' now commonly used to refer to marijuana, and am familiar with and hereby declare the following details:

My name is Pat McNulty and I affirm that the following is true. I lived in San Rafael, California (on Picnic Avenue) in Marin County and attended San Rafael High School in the early 1970's, as did my high school age older brother Bill McNulty. In the early 1970s, Bill and myself had a sister Marylin that was married to a U.S Coastguardsman and eventually a Coast Guard Reservist, our brother in-law Gary Philip Newman, who was stationed at the lighthouse stationed at Pt. Reyes California. We would happily visit them from time to time at Pt. Reyes. Gary and his wife eventually moved to a house just a few miles down the road from the Pt. Reyes lighthouse station, at the Nunes Ranch, and served as a ranch hand at the Nunes Ranch while serving in the Coast Guard Reserve. In the fall of 1971 while visiting Gary at the ranch, Gary had told my brother Bill and myself that he had planted a patch of marijuana nearby on the Pt. Reyes Peninsula that was ready to harvest. He was suddenly afraid to harvest the crop himself because they were planted on Federal property, and he was fearful that he would be busted by his anti-drug commanding officer. At his house Gary drew a map of the location of the cannabis patch and handed it to my brother Bill, giving permission to harvest along with anybody else Bill trusted. (As I observed the map being handed over to my

older brother, I admit that I was a bit jealous, given its importance and the level of confidentiality and trust.)

Bill went back to San Rafael High School with the map and approached his friend Steve Capper, and his core group of high school friends known as the Waldos (Steve Capper, David Reddix, Larry Schwartz, Mark Gravitch, and Jeff Noel) at the hang out wall on campus where they would regularly visit. The Waldos agreed that they would all meet and head out after school at 4:20 PM to get high and drive out to Pt. Reyes to find the marijuana crop depicted in Gary's treasure map. 420 Louie, 4:20, 420, four twenty --soon became their code words for marijuana.

In the many years that followed I would hear the term '420' four twenty used by others and knew that it had spread to other generations.

In February 2016 Gary Newman and I had a reunion with the Waldos and we went out to the Marin County Point Reyes Lighthouse where Gary had been stationed in the Coast Guard. The Waldos interviewed Gary and myself on camera/video about the map my brother Bill had given to the Waldos. I'm in the video on the right side of Gary being interviewed on camera. The video is titled 420 Treasure Map.

I declare under penalty of perjury under the laws of the State of California that the foregoing is true and correct and that this declaration is executed on the date

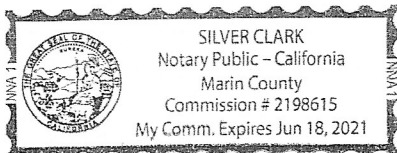

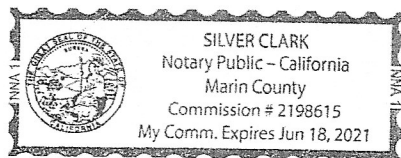
